Your Privacy

Pertubuhan BIM Malaysia (“PBM,” “we,” “us,” or “our”) respects the privacy and confidentiality of your personal information. This Privacy Policy explains how we collect, use, store, and protect your personal data when you engage with PBM, including through our website <https://www.pertubuhanbim.org.my>.

By using the Website or providing your personal data to PBM, you consent to the practices described in this Privacy Policy.

Collection and Use of Personal Data

PBM may collect your personal data for purposes including:
